#### GUIDELINES FOR VISITORS TO PROVIDENCE HEIGHTS (PH) Effective August 8, 2020

It is assumed that you are following the recommendations of the CDC regarding social distancing, wearing a mask, and hand hygiene. We recognize that your family and work commitments may make it difficult to assure that those you meet are following the above recommendations. If there is **any** chance that you may have been exposed to Covid 19, we respectfully request that you not put the residents at Providence Heights at risk by visiting at this time.

# **GENERAL**

- Nonresidents of Providence Heights MUST wear a mask while in the building and keep a safe distance from others
- All Visitors MUST complete the CHECKLIST and sign in and out at the reception desk
- The expectation is that the visitor will NOT have access to any areas within Providence Heights, but will visit with the PH resident in one of the parlors or outside, weather permitting. Both the visitor and the Sister they are visiting will wear masks during their visit.
- Sisters of Divine Providence visiting at Providence Heights will need to follow these same guidelines, except they will have access to other areas of the building as needed. Visiting Sisters will need to arrange with Sister Rose Anne Krantz if they want to stay at Providence Heights for a meal.
- Visitors to Saint Joseph Center will be handled through the Nursing Unit as it is considered a "high risk" area

# VISITING HOURS

• Opportunities for visiting will be between 10 am and 4:00pm

# CHECK LIST FOR ADMISSION TO PROVIDENCE HEIGHTS

- Receptionist will have a checklist that the visitor must complete and sign on arrival
- Once the checklist is completed the visitor will sign the log at the front desk as usual and sign out when leaving the building
- The receptionist will notify the person who is being visited so she may then come to the parlor to meet with her visitors while she too wears a mask.

### GUIDELINES FOR VISITORS TO ST JOSEPH CENTER (SJC)

## **GENERAL**

- All visitors to SJC will be scheduled through the nursing unit
- Visitors will be Sisters or family members only.
- Visitors will be limited to two persons at one time
- Visitors to SJC will complete the checklist with the nurse or aide before visiting the resident
- Visitors, inclusive of any Sisters of Divine Providence, and the resident being visited MUST wear a mask while in the Center and keep a safe distance from others as much as possible. No outside visitor may come to the residential area of SJC
- Sisters of Divine Providence visiting SJC area or residents should not come to the area if they feel ill, have a fever of 99F, have shortness of breath or have a dry cough

## VISITING HOURS

- Opportunities for visiting will be between 10:00 and 4:00pm.
- Sisters of Divine Providence may visit throughout the day and early evening following the same general guidelines at noted above

## CHECK LIST FOR ADMISSION TO ST JOSEPH CENTER

- Once the checklist is completed and acceptable. The staff will then take the resident to the designated area for the visit.
- It is recommended that the visit be limited to a maximum of one hour.
